This Privacy Policy applies to: www.grouperspotter.org (the "Website")

The respect of your privacy is of the utmost importance for Reef Environmental Education Foundation (REEF), who are responsible for the Website.

This Privacy Policy outlines:

the way your personal information is collected and processed. "Personal information" means any information that could identify you, such as your name, your mailing address, your email address, your location and your IP address. "Personal information" is a synonym for "personal data" within the meaning of the Regulation 2016/679 of European Union (General Data Protection Regulation);

- your rights regarding your personal information;
- who is responsible for the processing of the collected and processed information;
- to whom the information is transmitted;
- the Website's policy regarding cookies.

We may change, modify, add or remove portions of these Terms as well as Site functionality and the Services, at any time. Such revised Terms will be effective when posted on this Site. 1. COLLECTION OF PERSONAL INFORMATION

2. FORMS AND METHODS OF COLLECTION

Your personal information is collected through the following methods:

We use the collected data for the following purposes:

 - 1 Associating data with its original observers, defined as one or more individuals responsible for submitting the data and/or one or more individuals responsible for collecting related media (photographs, video, etc.), for future validation
 - 2 Confirming via email the stored link to the observers' submitted data
 - 3 Notifying the observers of curation events on the data
 - 4 Providing news updates via email

3. COOKIES AND LOG FILES

We collect information through log files and cookies. These allow us to process statistics and information on traffic on the Website, to ease navigation and improve your experience.

Under the General Data Protection Regulation (European Regulation 2016/679), the use of cookies and log files that involves personal information saving and analysis requires your consent.

Your consent is valid for the duration of the retention of the images submitted by you.

a) Cookies used by the Website

The cookie files used by the Website are the following:

10. GENERAL PRINCIPLES RELATING TO THE COLLECTION AND PROCESSING OF PERSONAL DATA UNDER EUROPEAN REGULATION 2016/679

In accordance with the provisions of Article 5 of European Regulation 2016/679, the collection and processing of your personal data comply with the following principles:

- Lawfulness, fairness and transparency: your personal data may only be collected and processed with your consent. Every time your personal data is collected, you will be informed that your personal data is being collected and for which reasons your personal data is collected;
- Limited purposes: the data is collected and processed for one or more purposes set out in this Privacy Policy;
- Data minimisation: only personal data necessary for the purpose to which it is necessary is collected;
- Storage limited in time: personal data is stored for the duration of the period in which the images submitted by you are retained by the Website;
- Integrity and confidentiality of collected and processed personal data: The Controller is committed to maintain the integrity and confidentiality of the collected personal data.

In order to be lawful and to comply with Article 6 of European Regulation 2016/679, collection and processing will only occur if one of the following applies:

- You have given your express consent;
- Processing is necessary for the performance of a contract;
- Processing is necessary for compliance with a legal obligation;
- Processing is necessary in order to protect your vital interests or those of another physical person;
- Processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority;
- Processing is necessary for the purposes of the legitimate interests pursued by the Controller or a third party.

11. ADDITIONAL RIGHTS PURSUANT TO EUROPEAN REGULATION 2016/679

In accordance with European regulation relating to the processing of personal data, you also have the rights listed below.

The Controller must answer your request within a period of thirty (30) days.

b) Right of not being the object of a decision based only on automated processing

In accordance with the provisions of the European Regulation 2016/679, you have the right of not being the subject of decision based solely on automated processing if the decision produces legal impact concerning you or significantly affects you.

c) Right to submit a complaint to the competent authority

If the Controller does not answer your request, you wish to challenge his or her decision or you believe one of your rights has been infringed upon, you have the right to submit a complaint to the competent authority.

Personal information we collect is stored in a secured environment. People working for us are obligated to respect the confidentiality of your personal information.

13. PERSONAL DATA OF MINORS UNDER EUROPEAN REGULATION 2016/679
